## **Maritime Security and Blue Economy**

In preparation to the UN Ocean's Conference 2020, hosted the Kenya has first Global Blue Economy Conference from the 26th - 28th of November 2018, in Nairobi. The discussions focused on the priorities and challenges of establishing a sustainable Blue economy and its contributions to the implementation of the 2030 Agenda for Sustainable Development including maritime safety and security.

On the third day of the conference, the Director of the Eastern Africa standby Force, Dr. Abdillahi Omar Bouh addressed the delegates. In his presentation the EASF Director highlighted importance of information sharing "a critical component of achieving and enhancing Maritime Domain awareness (MDA) is the development regional information sharing. EASF is in the process establishing the information sharing network through agreements with the member states and memorandums of

understanding with other regional organizations such regional coordination and operations center" said Dr. Bouh.

The Director also pointed out that EASF has conducted courses for the several member states on maritime operations planning, integrated mission planning and maritime search and rescue. These courses have enhanced the capacity and expanded the capability of the region in planning and executing maritime operations.

The event was attended by several ministers, delegations from UN member states, heads of various UN agencies and international organizations, private sector, academia and Civil Society Organizations.

Different speakers lauded Kenya for showing leadership and demonstrating commitment to the world on how to build a Blue Economy with Japan indicating they will partner with Kenya and Canada to ensure the success of the first global conference that seeks to build on the momentum of the UN's 2030 Agenda for Sustainable Development.

## **Enhancing Partnership with Friends of EASF**




The ordinary meeting of the Friends of EASF took place on Friday 9th November at the Sankara Hotel, in Westlands, Nairobi, Kenya.

### **EASF Civilian Roster Verification**

The Civilian Component of the Eastern Africa Standby Force (EASF) conducted two roster verification this year. The first one was in the Democratic Republic of Ethiopia and the second in the Republic of Djibouti.

The aim is to verify the deployment suitability of civilian personnel from its Member States who have been trained for Peace Support Operations (PSOs).



The exercise gives the opportunity to see a number of PSOs Trained Civilians from EASF Member States being evaluated in accordance with the African Union's roistering principles and conduct interviews with civilian personnel to join the African Standby Capacity. The Roster Verification exercise has a high impact at a regional and continental level in supporting peacekeeping missions to address the challenges of protecting civilians as well as to maximize the participation of civilian personnel in integrated and multidimensional peacekeeping missions.

## Maritime Search & Rescue Course Successfully Conducted in Seychelles



During the first week of October 2018, EASF conducted a two-week Maritime Search and Rescue course (SAR) in Victoria, Seychelles. The aim of the course was to train and equip naval, coastguard officers and maritime rescue coordination centers (MRCC) staff with skills that would enable them respond to any emergencies or distress at sea.

This course was the first course

to be run by the EASF Regional instructors, after the hand-over of the course from Nordic instructors (NACS) at the end of August 2018. The overall Objective of this course was to improve the regional coordination of maritime operations from shore-based to other government agencies who deal with maritime safety and security in order to respond to incidents in the regional maritime zones.

The course was attended by 31 participants from Burundi, Comoros, Djibouti, Kenya, Rwanda, Seychelles, Sudan, Uganda, EASF Maritime Planning Cell Staff as well as the Regional Center for Operation Coordination staff personnel.

## **EASF Spokesperson Training**

The Eastern Africa Standby Force (EASF) conducted a spokesperson training for the management team of the organisation in September 2018 in Naivasha, Kenya.

The aim was to enhance the capability and competency of the EASF management in undertaking the roles and functions of spokespersons for EASF and to provide them with the skills to effectively address the media.



## **EASF Experts Working Group Meeting**



The Eastern Africa Standby Force Experts' W o r k i n g Group Meeting got going in September at the Secretariat, in Karen, Kenya. According to the decision of

24<sup>th</sup> Ordinery Policy Organs' Meetings, the Experts Working Group Meeting is being held to review the Rotation Matrix of the organisation for consideration and approval by the 25th Policy Organs' Meetings (POMs) which is due to take place in Khartoum, the Republic of the Sudan from 12<sup>th</sup> – 17<sup>th</sup> December 2018.

The Staff rotations are usually rolled out alphabetically among the ten EASF Member States in order to ensure an equitable approach in representation within the Standby Force.

## EASF Director Courtesy Call to Japanese Mission to AU

The Director of EASF, Dr. Abdillahi Omar Bouh held a key meeting with the Deputy Head of Japanese Mission to the African Union Mr. Tetsuya Unno who was accompanied by the Japanese Defence Attaché to Ethiopia, Colonel Hidemasa Murata on 5<sup>th</sup> October 2018. The meeting took place at the Japanese Mission to African Union Offices in Addis Ababa, Ethiopia.

Dr. Bouh informed both Mr. Tetsuya Unno and Colonel Murata about the activities held in 2018. He expressed the desire to build bridges across





the global arena and also making sure that the Standby Force maintains its critical role in capacity building.



## **EASF SOPs Workshop**

EASF held the Standard Operating Procedures (SOPs) review workshop for Mission Headquarters (MHQ) and Force Headquarters (FHQ) at the Kenya Commercial Bank Leadership Centre in Karen, Nairobi, in November 2018.

The workshop, which was opened by the EASF Joint Chief of Staff Major General (Dr) Charles Rudakubana was guided by the Requirements' Paper compiled after the Field Training Exercise (FTX) 2017's After Action Review



(AAR). This paper clearly spells out the various gaps identified in both Mission Headquarters (MHQ) and Force Headquarters (FHQ) during the successfully concluded FTX 2017.

The workshop has produced two Operating Handbooks which will steer the two headquarters in future Peace Support Operations' missions and practical training exercises.

## **Integrated Human Rights Course**



EASF conducted the Integrated Human Rights (IHR) course at the International Peace Support Training Centre (IPSTC) Nairobi, Kenya, on 19<sup>th</sup> November 2018.

The course was aimed at building and enhancing the capacities of the various actors who will be involved in multi-dimensional peace operations to ensure Human Rights' awareness, compliance, effectively addressing Human Rights violations and mainstream Human Rights principles and practices. The Integrated Human Rights course was planned to help EASF to increase available capacities in the areas of Human Rights during peace operations.

## **UN Military Experts on Mission Course**

A three-week United Nations Military Experts on Mission (UNMEM) course, attended by five Eastern Africa Standby Force (EASF) Member States was held in Musanze, Rwanda, in November 2018.

The course intended to train military officers who will later serve in UN peacekeeping operations as military observers, military liaison officers and military advisers.



## EASF's Internal Staff MP & MS Workshop

A three-day Mission Planning and Management Section Workshop was held between 27<sup>th</sup> to 29<sup>th</sup> November 2018 at the EASF Secretariat in Karen, Nairobi.

The workshop was organised to enhance the EASF's Leadership and Mission Planning & Management Section (MP&MS) about their operational roles and responsibilities in the event of a regional or continental deployment.

During the opening ceremony, the EASF Director Dr. Abdillahi Omar Bouh reassured his commitment in ensuring that the Standby Force remains ready at any time should the need for deployment arise.

## **Strengthening the Police Force**

The Police component in the EASF with the financial support of the African Union organised a two-week course aimed at strengthening Command, Control and Communication of formed police unit (FPU).

Over 30 participants from EASF member states attended the training which was held in Djibouti from 22<sup>nd</sup> October to 9<sup>th</sup> November, 2018. It was also the first time for Djibouti to host



such high level training for formed police units. The commanders' course is very crucial because the FPUs play a very important role in the Peace support operations (PSOs) by providing security support to the UN/AU operations by ensuring the safety and security of the UN/AU personnel and assets, contribute to the protection of civilians and also support police operations in general.
